**-CLUB STATUS**

-It was motioned and seconded to leave **Jefferson** on probation for one additional year. The motion passed. The **Jefferson** Board and all Head Coaches must attend the pre-weigh-in paperwork audit.

-It was motioned and seconded to re-instate **Springfield** to full status. **The motion passed.** All **Springfield** head Coaches must attend the pre-weigh-in paperwork audit.

-It was motioned and seconded to accept **Springboro** as a full status member. **The motion passed .**

-It was motioned and seconded to re-instate **Beavercreek** to full status member. **The motion passed.**

**-BY-LAWS UPDATE**

-Various By-Laws were discussed, motioned and voted on. A comprehensive list is published on page 4.

-It was motioned and seconded that no team may play in the post-season tournament if they only have one team at that grade level, unless a waiver is granted from the WOJFC. **The motion failed.**

-It was motioned and seconded that new clubs must field two teams at 4th, 5th and 6th grade levels. **The motion failed.**

-It was motioned and seconded that no coaches will be permitted on the field after the fourth game in 6th grade. **The motion failed.**

-It was motioned and seconded to have all player’s residency confirmed by the first day of practice. **The motion passed.**

-It was motioned and seconded to donate \$500.00 to each fundraiser in the name of Cody Lundy and Ethan Conley. **The motion passed.**

-Holiday Inn contract reviewed, it was motioned and seconded to renew the contract. **The motion passed.**

-It was motioned and seconded to use Nutter Center for all WOJFC events. **The motion passed.**

**By-Laws reviewed, Proposed changes in By-Laws;**

1.2.2 to read "received by February meeting". It was motioned and seconded. **The motion passed.**

1.2.4 It was motioned and seconded to delete "mandated secret ballot". **The motion passed.**

1.5.1 Playing rules reviewed, 1.5.1 reviewed, **A motion was made, no second.**

1.5.1 It was motioned and seconded to rescind no talking policy to revert back to previous policy. **The motion failed.**

1.5.4 It was motioned and seconded to remove from By-Laws 1.5.4, thus removing mandatory HC meeting and place responsibilities at club level to ensure compliance by all coaches with written verification. **The motion failed.**

1.14.3 It was motioned and seconded to remove incidental face mask rule. **The motion failed.**

4.3.1 It was motioned and seconded to amend 4.3.1 to change verbiage from "can" to "must". **The motion passed.**

9.8.4 It was motioned and seconded to add "signed by site rep or alternate" to 9.8.4. **The motion passed.**

The following rules were reviewed with no motions or seconds; 1.4.1, 1.6.2, 1.7.1, 1.8.4, 9.7.8, 10.3.1, 10.3.3A, 10.3.3.1, 10.3.3.2, 10.3.3.3, 13.2.3, 14.4.2, and 14.4.3.

It was motioned and seconded to permit on field time outs. **The motion passed.**

It was motioned and seconded to allow live kick off's in 5<sup>th</sup> and 6<sup>th</sup> grade. **The motion failed.**

It was motioned and seconded to increase weight limits 5lbs. across the board for each grade. **The motion failed.**

It was motioned and seconded to appoint 3-5 man competition disciplinary committee to establish consequences for infractions by coaches. **The motion failed.**

Reviewed Article II, amend to read, "there are no appeals for any infractions", It was motioned and seconded. **The motion was withdrawn.**

Request to decrease sideline personnel from 10 to 5, **No motion.**

Playing rules reviewed from Survey, Gloves reviewed, **No motion.**

Surveys reviewed, term limits for E-Board members discussed. **No motions or seconds.**
